LIMITED REGISTRATION PUPPY SALES CONTRACT

Under the terms of this agreement, the undersigned parties agree to the following with regard to the sale of Puppy (Sex: _____ Date whelped: _____ Sire: _____ Dam: _____).
The purchase price will be \$ _____ (less \$ _____ deposit) plus all related shipping and/or other costs.

As Buyer(s) of the above described Puppy, I (we) agree:

1. If Buyer has a concern about the health of Puppy, Buyer will have Puppy examined by a licensed veterinarian within seventy-two hours of receipt by Buyer(s). If the veterinarian determines Puppy to be ill, Buyer(s) may return Puppy for a full refund, provided it is in the same condition as at the time of purchase.
2. Preventive care will be exercised toward Puppy with regard to hip dysplasia. Such care shall include, but not be limited to: proper nutrition, proper weight for age, proper exercise, and prevention of stress injuries (e.g., not allowing Puppy to jump from heights taller than its elbows and no forced exercising until at least twelve months of age) -- see attachment for details.
3. Puppy will be given adequate and proper shade and housing, and be properly and sufficiently fed.
4. Puppy will not be neglected in any manner nor mistreated in any way.
5. Puppy shall receive proper veterinary care and vaccinations throughout its lifetime.
6. Puppy will be protected from theft, loss or injury due to lack of control of Puppy, inadequate confinement behind a fence etc., or from riding in the back of an open vehicle.
7. Buyer(s) shall promptly notify Seller(s) of any address change made by Buyer(s).
8. Buyer(s) shall promptly notify Seller(s) of any titles awarded by AKC or other organizations to Puppy.
9. Puppy shall not be used for purposes of vivisection in any form.
10. Should circumstances warrant selling or "placing" Puppy at any time, Buyer(s) will notify Seller(s) and thereby give the Seller(s) the first option to take Puppy back.
11. Puppy will not be sold or given to a pet shop, pet agent, or broker, or to persons outside the United States or Canada either directly or indirectly.
12. Puppy is sold on an AKC Limited Registration and it will not be bred.

As the breeder, Seller(s) agrees as follows:

It is a goal of the breeder to improve the breed by reducing the incidence of diseases of genetic origin. If health disorders of suspected genetic cause arise in Puppy the breeder should be consulted. Reasonable precautions have been taken to prevent Puppy from acquiring faults such as hip dysplasia, cataracts or other eye disorders, heart defects etc. Hip, elbow, eye, and heart clearances of both parents have been obtained.

No guarantees or warranties, expressed or implied, as to the suitability of this puppy/dog for any type of competition or other purpose are given by the seller(s). Puppy is sold and delivered in an "as is" condition, except as expressly and specifically set forth herein. **I/we have read and understand all the above terms and conditions and find them mutually agreeable and acceptable.**
