## STUD DOG CONTRACT

The owners of the above named dog and bitch are in agreement of the following terms and conditions regarding the breeding of the above named Golden Retrievers:

1. Prior to breeding, the bitch owner(s) will provide the stud dog owner with copies of the following: OFA hip, elbow, and heart (by cardiologist) clearances; current CERF eye clearance; 3 generation pedigree; current immunization record; photo; and negative brucellosis test done within 10 days of breeding (brucellosis test not required for shipped semen).
2. The bitch is free of communicable disease, internal and external parasites.
3. The stud fee shall be \$1000. A fee of \$200 (non-refundable Breeding Fee) is due at the time of the breeding and the balance of \$800 is due when the stud dog owner signs the litter registration. The full stud fee is charged for three or more live puppies achieving 3 days of age. For two puppies or less, the stud fee will be \$200 per puppy (over and above the non-refundable Breeding Fee) and there will be no further obligation on the part of the bitch owner(s) or the stud dog owner. If no litter results from this breeding, no additional payment will be due to the stud dog owner and there will be no further obligation on the part of the bitch owner(s) or the stud dog owner.
4. Ten days board is included in the Breeding Fee. If the bitch is maintained at the stud dog owner's property for more than 10 days the bitch owner(s) agrees to pay an additional \$15 per day.
5. The stud dog owner will prepare and analyze vaginal smears as needed (determined by the stud dog owner) at no additional charge. Any additional veterinary or other services related to the care and maintenance of the bitch are the responsibility of the bitch owner(s). Should the bitch become ill, the owner(s) of the bitch authorizes all immediate and necessary care and will be responsible for any and all veterinary charges. If semen is to be shipped, all expenses related to collecting, shipping, and inseminating the bitch are the responsibility of the bitch owner(s).
6. Breeding will occur as soon as the bitch will allow and then subsequently every 36-48 hours for as long as the bitch will stand or until vaginal smears indicate the fertile period is over. In the event of an inability to achieve a natural tie, the stud dog owner or her agent will perform artificial insemination on the bitch for no additional charge.
7. The bitch owner(s) holds the stud dog owner harmless for any and all illness/injury/death, which may occur in the course of this contract (during or as a result of this breeding). Under no circumstances is the stud dog owner responsible legally or financially for any illness/injury/death that may occur during or after this breeding.
8. Uncontrollable or destructive behavior will be cause to return the bitch to her owner(s).
9. The owner(s) of the bitch is responsible for transportation of the bitch to and from the stud dog owner's residence. If the bitch is shipped for breeding, all expenses for shipping to and from Denver International Airport will be paid in advance by the bitch owner(s).
10. The bitch owner(s) agrees none of the puppies from this service shall be sold to a pet shop, agent, or broker. The bitch owner(s) agrees to sell full registration puppies from this breeding with a contract forbidding the sale of the dog to a pet shop, agent or broker. The bitch owner(s) agrees that pets sold from this litter will be sold with limited registration and spay/neuter contracts.
11. The bitch owner(s) will provide the names, addresses, phone numbers, and AKC litter numbers of all puppy buyers to the stud dog owner.

After reading the above terms and conditions, we find them mutually agreeable and acceptable.
